She has been member of the Board of Directors and President of the Scientific Board of Instituto Superior Técnico (Technical University of Lisbon). She is a member of 22 national and international scientific associations and fellow of AIAA-American Institute of Aeronautics and Astronautics, of AAAS-American Association for the Advancement of Science, of the WAAS - World Academy of Art and Science and of the Portuguese Academy of Science.

She published 115 articles in international scientific journals and more then 300 articles in international books and proceedings of conferences. She is author of 2 books and editor of 14 books and special editions of international scientific journals. Her main area of research is Energy, Climate Change and optimization of energy intensive industries.

Rudi Delarue has been Director of the ILO (International Labour Organisation) Brussels office for the EU and the Benelux countries since June 2008.

Prior to taking up this post he was a principal administrator at the European Commission since 1999 where he held posts relating to international affairs (relations with the ILO, G8, the interplay between development, trade, employment and social policy, the social dimension of globalisation and decent work) and to EU social dialogue. He was involved in the EC preparatory work on the European Consensus for Development and on the update of the EU trade mandate and instruments in relation to labour issues.

Between 1987 and 1999 he worked for the Christian trade union confederation of Belgium (ACV/CSC) and was dealing with employment and social policy, labour standards, social dialogue and

capacity building training for trade unions at regional, national, EU and international level. He was member of the Belgian National Labour Council and assistant of the workers spokesperson at the ILO tripartite Committee for the Application of Labour Standard between 1989 and 1999. He was part of the ETUC negotiating team in EU cross industry social dialogue. Mr Delarue was born in 1963 in Tienen, Belgium. He graduated with a Law degree from the Catholic University of Leuven in 1986 and subsequently pursued European studies at the College of Europe in Bruges. Sven Otto LITTORIN, former Swedish Minister of Employment

Mr. Sven Otto Littorin is an entrepreneur in business and politics and is currently an independ-ent advisor, based in the UK, where he advise British, US and Scandinavian clients as well as the European Commission on change management, policy reform and related issues. He is also a Special Advisor to Firpa International, a global government relations advisory firm, and a director of the Swedish School in London.

In the spring of 2011, he was a visiting scholar at the Center for Innovation and Communication at Stanford University, developing the link between innovation and jobs and the interaction between creation of policy and public discussion, crossing the traditional verticals of government. Between 2006 and 2010, Mr. Littorin was Sweden's Minister for Employment, in charge of USD 15bn of the government budget; the second largest part of public spending, covering areas such as the unemployment insurance system, active labor market programs and nine govern-ment agencies, including the Swedish Public Employment Service, the Work Environment Au-thority and the Labor Court.

During the Swedish Presidency of the European Union in the fall of 2009, Mr. Littorin was also President of the European Council of Ministers, in its Epsco formation (Ministers for Employ-ment, Social Policy, Health and Consumer Affairs In the previous election term, 2002-06, Mr. Littorin was the Secretary General of the Moderate Party. As such, he served as the

party's "CEO", in charge of a USD 20m budget, a staff of over 100 persons, 60.000 members and 6.000 elected representatives on local and national levels. He was also in charge of campaigns and campaign funding and other related issues.

Prior to his public assignments, Mr. Littorin founded and ran Momentor, a Venture Catalyst firm, for five years. Momentor, with affiliations in the US and in China, specialized in early-stage companies and start-ups.

Mr. Littorin was a board member of several small and medium-sized corporations and organi-zations. He was also a member of the Public Policy Committee of the Agency for Economic and Regional Growth, a member of the Advisory Board for the Executive School at the Royal Insti-tute of Technology and a Special Director for the Swedish-American Chamber of Commerce, SACC-USA, Inc

In 1991-93 Mr. Littorin served as Chief of Staff to the Minister for Fiscal and Financial Affairs at the Ministry for Finance, during the worst financial crisis that Sweden has ever experienced.

Mr. Littorin is an Artillery Officer and earned his degree in Economics and Business from Lund University in Sweden. He has published four books in economics and social sciences.
