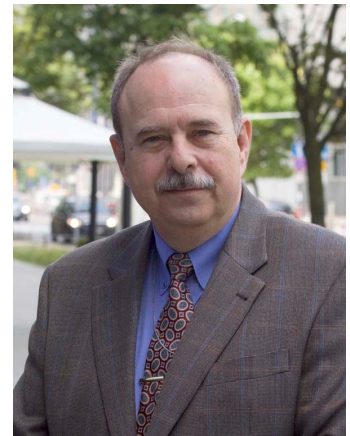
Monika Štajnarová works as an Economic Officer at BEUC, the European Consumers' Organisation representing 39 independent national consumer associations, in 30 European countries.
